

## Sublicense Agreement to use the Computer

### Program IBM No.

REPUBLIC OF IRELAND

#### FULL NAME,

hereinafter referred to as the Licensee, acting in its own name and in its own interests as an individual, on the one hand, and **BROADMIND LIMITED**, hereinafter referred to as the Licensor, on the other hand, have entered into this agreement (the "Agreement") on the following.

### Definitions and Interpretation

1. **Licensee** - an individual who is interested in purchasing a license for the product MASTERKIT.

2. **Licensor** - a legal entity selling the license of the product "MASTER KIT .

3. **The licensed product MASTER KIT** is an intangible product (directly satisfying the needs of the Licensee (the User of the product) in using its internal resources to achieve its goals), consisting of text, audio and video information.

4. **Online support** - a communication of the Licensor's employees with the Licensee through correspondence and virtual communication on the Internet in the "question-answer" way, regarding the licensed product MASTER KIT .

5. **Training tool for practical work** - an information system using a speech synthesizer that provides the Licensee with understanding of internal mindsets that prevent him from achieving his goals.

6. **Offer** - this document is published on the website [super-ego.one](http://super-ego.one)

7. **Offer Acceptance** - full and unconditional acceptance of the Offer by carrying out the actions specified in clause 1.3. Offers. The Offer Acceptance creates a Contract.

8. **Signing of documents and agreeing to the terms of the agreement** - by signing (agreeing) documents, the Parties agreed to consider:

- the Licensee enters into this Agreement of its authentic full name, passport data and contact information;

- the Licensee submits an electronic clique (tick marking), by a PC mouse in specially-allocated places of electronic forms of this Agreement.

### 1. The Subject of the Agreement

1.1. In accordance with this Agreement, the Licensor grants to the Licensee the license to use the Computer Program IBM **MASTER KIT** for its own purposes, and not for further sublicensing.

1.2. The license is granted to the Licensee with respect to the right to reproduce the rightfully acquired and lawfully used Program for the entire duration of the exclusive right.

1.3. The agreement is deemed to have been executed provided that the Licensor fulfills the obligations stipulated in clause (3.3.1., 3.3.2.) Bonus support - The training tool for performing practical work is provided from the date of purchase.

1.4. The Licensee accepts the Offer Acceptance by paying a license for the purchase of **MASTER KIT** to the Licensor with respect to which the Agreement is concluded.



## 2. Payment terms

- 2.1. The license cost under this agreement is calculated according to the appendix 1 (price list)
- 2.2. Payment is made by the Licensee at one-time 100% prepayment at the conclusion of this Agreement, after which the Licensee receives the right to bonus support. - The training tool for practical work is guaranteed from the date of purchase.
- 2.3. The license is paid by the Licensee in a non-cash way by transferring funds to the Licensor's account or making it available to the Licensor under a cash-order warrant.

## 3. The Rights and Liabilities of the Licensor

- 3.1. The licensor has the right to receive full payment of the license cost.
- 3.2. The licensor has the right at any time to change the cost and terms of this public offer unilaterally without prior agreement with the Licensee, while ensuring the publication of the modified terms on the Internet resource at **super-ego.one** no less than one day before they are activated.
- 3.3. During the validity of this agreement, the Licensor shall:
  - 3.3.1. grant access to the licensed product **MASTER KIT** under an individual link located on the Internet;
  - 3.3.2. provide and transfer the licensed product **MASTER KIT**;
  - 3.3.3. as a bonus for the purchase of the product, provide online support of information system of the training tool from the date of purchase;
  - 3.3.4. not disclose personal information received from the Licensee, the confidentiality of which will be clearly stipulated by the Licensee;

## 4. The Rights and Liabilities of the Licensee

- 4.1. During the validity period of this agreement, the Licensee undertakes to:
  - 4.1.1. provide the Licensor (by entering them into this Agreement) reliable data: full name, passport and contact information in order to provide him with the most effective and prompt service;
  - 4.1.2. before signing this Agreement, to inform the Licensor (personally the Manager of the Licensor and confidentially) of the previous conviction for crimes against the person, mental illnesses, physical and psychological traumas and suffering, about the condition registered in the psychoneurological dispensary (the Parties agreed to consider this item as an essential condition of the actual agreement);
  - 4.1.3. pay for services of the Licensor with 100% prepayment thereby carries out the Offer Acceptance;
  - 4.1.4. not give access to the resources provided by the Licensor to third parties without the consent of the Licensor, since the information product "MASTER KIT" being a property of value to the Licensor is a trade secret;Do not copy or distribute the entire product as a whole or in parts. This mode of access and confidentiality is regulated by FA-No.149 dated July 27, 2006 "On Information, Information Technologies and Information Protection". The Parties agreed to consider this



item as an essential condition of this Agreement.

4.1.5. During the period of using the product, refrain from drinking alcohol and tobacco products (of any kind and concentration) and reduce (or, even better, exclude) watching of TV programs. If possible, focus on the process and information content of the Licensor's product. This directly determines the clarity of the Licensee's consciousness, deep understanding and qualitative assimilation of the information product, which entails the correctness and effectiveness of its subsequent application by the Licensee

## **5. Validity, grounds and procedure for changing and terminating the Agreement**

5.1. This Agreement comes into force from the moment of Acceptance by the Licensee and is valid until the parties fully fulfill their obligations under it.

5.2. All changes and additions to this Agreement are valid if they are executed in writing and signed by both parties.

5.3. The Licensor has the right to terminate this Agreement ahead of schedule unilaterally in case the Licensee violates the requirements of clauses 4.1.1. 4.1.2. and 4.1.4. of the actual agreement. At the same time, the Licensor is not obliged to notify Licensee in advance of the decision taken and the money paid by the Licensee is not refundable.

The licensor may refuse to provide access to the licensed product *MASTER KIT*, in case that the Licensee has a criminal record for crimes against the person, mental illness, physical and psychological trauma and suffering, if the Licensee is registered with a psychoneurological dispensary. In the above cases, the Licensor has the right to stop access to the licensed product *MASTER KIT*, if access was granted as a result of the information being concealed by the Licensee.

5.4. The licensee has the right to terminate this Agreement ahead of schedule unilaterally and to demand the return of the money paid for by him if the Licensor does not fulfill his obligations under the Agreement (clauses 3.3 of this Agreement). Herewith, the Licensee must prove that the Licensor has intentionally violated its obligations under this Agreement (clauses 3.3.) to the detriment of the purpose of this Agreement (the purpose of the agreement is reflected in terms used in the agreement).

In this case, the funds paid by the Licensee are refundable after deducting expenses actually incurred by the Licensor for duly executed obligations under this Agreement.

Herewith, the Licensee shall notify the Licensor in writing about the forthcoming termination not later than 3 (three) calendar days before the termination of this Agreement.

5.5. The Parties have the right to terminate or suspend validity of this Agreement ahead of time in case of force majeure. In this case, the funds paid by the Licensee are subject to return by the Licensor in the amount and on the terms agreed by the parties in a mutual agreement.

## 6. Confidentiality

6.1. The accounts transferred by the Licensor to the Licensee constitute confidential information of the Licensor and should not be copied by the Licensee, and also be provided to third parties during the validity of this Agreement and after its termination.

6.2. The Parties shall take all measures to preserve the confidentiality of other financial, technical or other information received from each other under this Agreement with the "Confidential" or "Commercial Secret" sign during the validity of the Agreement, and after its termination without limitation.

## 7. Applicable Right and Dispute Resolution

7.1. The Law of the International Private is applicable to the present Agreement without reference.

7.2. All disputes under this Agreement are decided by the parties through negotiations. If the parties could not come to an agreement on disputable issues through negotiations, the disputes should be resolved in the courts at the location of the Licensor.

## 8. Concluding Regulations

8.1. The present Agreement is made in two copies.

8.2. All notification sent by the Parties to each other within the framework of this Agreement shall be in writing, except for cases when another form of notification is envisaged in this Agreement
